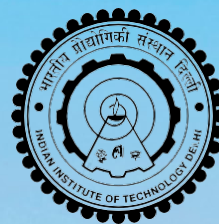

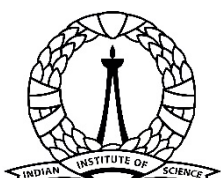

# SALIENT POINTS

- **IIT Delhi is the Organizing Institute for JAM 2025.**
- JAM 2025 Examination was conducted on Sunday, February 02, 2025 for the SEVEN Test papers, viz., Biotechnology (BT), Chemistry (CY), Economics (EN), Geology (GG), Mathematics (MA), Mathematical Statistics (MS) and Physics (PH).
- Candidates who have secured marks greater than or equal to the cut-off marks of their respective category are eligible to apply for JAM 2025 admissions.
- Admissions to over **3000** seats across **105** postgraduate programmes at 22 IITs will be coordinated by IIT Delhi for the academic year 2025-26.
- Post-graduate programmes such as M.Sc., M.Sc. (Tech), M.S. (R), Joint M.Sc. - Ph.D., M.Sc. - M.Tech. Dual Degree, M.Sc. - Ph.D. Dual Degree are available for admission through JAM 2025.
- Applications are to be submitted through JAM 2025 website from **26 March to 09 April 2025**.
- Candidates seeking admission have to pay a non-refundable application fee of ₹750/-
- Candidates who have submitted the Application Form can modify their programme choices till 5 May 2025
- Candidates should regularly check for offer of seats and exercise their decision through the Application Portal.
- Candidates who have been offered and accepted the seat should pay a Seat Booking Fee of ₹15,000/- for General/OBC-NCL/EWS category and ₹7,500/- for SC/ST/PwD category ONLINE within the stipulated time.

## 1. INTRODUCTION:

The Indian Institutes of Technology (IITs) are institutions of national importance established through an Act of Parliament in 1956. Joint Admission test for Masters (**JAM**) is conducted by IITs since 2004-05 and has evolved as the de-facto examination used for admission to a large number of postgraduate programmes in IITs, IISc, IISERs and NITs. The objective of JAM is to help a large number of bright undergraduates in science stream to pursue science as a career option. These programmes offer high-quality education in their respective disciplines, comparable to the best in the world. The curricula for these programmes are designed to provide the students with opportunities to develop academic talent leading to challenging and rewarding professional life. The curricula are regularly updated at the IITs. The interdisciplinary content of the curricula equips the students with the ability to utilize scientific knowledge for practical applications. These programmes are open to all eligible students irrespective of their nationality. The medium of instruction is English for all the above-mentioned programmes. A number of financial assistantships are available to SC, ST and other deserving/meritorious students at IITs. IIT Delhi is the Organizing Institute for JAM 2025 examinations and also the coordinating institute for admissions. JAM 2025 Examination was conducted on Sunday, February 02, 2025 as a Computer Based Test in SEVEN Test Papers, namely, Biotechnology (BT), Chemistry (CY), Economics (EN), Geology (GG), Mathematics (MA), Mathematical Statistics (MS), and Physics (PH). The results for this examination will be declared on **March 18, 2025**.

## 2. ADMISSION PROGRAMMES:

The results of JAM 2025 will be used in admission to over **3000** seats in **105** postgraduate programmes across **22** IITs for the academic year 2025-26. The list of Admitting Institutes along with their website and contact details is given in Annexure I. Candidates are advised to visit the corresponding website and look at the profiles of the Admitting Institutes, and the curricula of the academic programmes. The seat matrix and MEQs for the different programmes is given in Annexure II.

**Eligibility Requirements (ERs):** Candidates who obtained marks above the cutoff marks (for the respective category) are eligible to apply for admissions to IITs, provided they satisfy the following:

- Candidates should have passed an undergraduate degree or should be currently studying in their final year of undergraduate programme. Proof of having passed the undergraduate degree must be submitted within the timeline provided by the respective admitting Institute.
- Candidates promoted without a marksheet should produce a certificate stating the subjects studied in that semester/year duly signed by the Head of the Institute.
- Foreign nationals with Indian degree are eligible to apply, subject to policy of the Admitting Institute.

**Minimum Educational Qualifications (MEQs):** Each programme has its own set of Minimum Educational Qualifications, which specify the essential subjects to be studied during Bachelor's Degree. The MEQs and seat matrix for various programmes at the Admitting Institutes are listed in a consolidated table in Annexure II. Verification of Minimum Educational Qualifications (MEQs) and the Eligibility Requirements (ERs) for admission is the prerogative of the Admitting Institute only and the Organizing Institute will not respond to any queries in this regard.

For candidates satisfying the ERs, MEQs and other necessary requirements, JAM All India Rank (AIR) will be used to admit the candidates **without any additional interview or written test**. At the time of admission, all admitted candidates may have to submit a Physical Fitness certificate from a registered medical practitioner in the prescribed form to the Admitting Institute. The admitted candidates may also have to undergo a Physical Fitness test by a medical board constituted by the Admitting Institute. In case candidates are not found physically fit to pursue their chosen programme of study, their admission is liable to be cancelled.

### 3. RESERVATIONS POLICY:

In each programme, a certain number of seats as listed in Annexure II are reserved for candidates belonging to various categories as per the Government of India rules. Candidates who seek admission under SC or ST category must submit the requisite certificate issued by a competent authority as specified in Annexure III. Candidates who seek admission under the OBC-NCL or EWS Category must submit a valid OBC-NCL or EWS Certificate issued by a competent authority specified in Annexure III, in a format similar to that shown in Annexure IV for OBC-NCL and Annexure V for EWS. Valid certificates for OBC-NCL or EWS issued on or after April 1, 2024 should be submitted for application processing.

Candidates who seek admission under PwD category must submit a disability certificate (refer Annexure III) or Unique Disability Identification (UDID) certificate. Benefits of reservations would be given only to those who have benchmark disability i.e. not less than 40% impairment irrespective of the type of disability. Such candidates must submit, along with the filled-in Application Form, the Certificate of Disability from a Government Medical Board and should be fit to pursue the Programme. The certificate should be preferably in the format given in the Form V or Form VI or Form VII (as applicable) in the Rights of Persons with Disabilities Rules, 2017. The disability percentage of candidates selected for admission in PwD category may also be required to be certified by a Medical Board, duly constituted by the Admitting Institute. ### 4. APPLICATION PROCEDURE:

- Applications for Admissions must be submitted online at <https://joaps.iitd.ac.in> by paying a non-refundable application fee of ₹750/-.
- Only candidates in the JAM 2025 Merit List will be eligible to apply for admission. Irrespective of whether a candidate appears in the Merit List of one or two Test Papers, only one duly completed Application Form should be submitted.
- The Application Form in the admission portal will be pre-filled with (i) Name, (ii) Category, (iii) Date of birth, (iv) Gender, (v) PwD Status, (vi) Parent's/Guardian's name, (vii) Mobile number, (viii) Email id, (ix) Photograph, (x) Signature, (xi) Category certificate and (xii) Physical Disability Certificate using the information provided during the application process for JAM Examination (or, corrected subsequent to the exam).
- The candidates are requested to verify the details on the candidate portal (<https://joaps.iitd.ac.in>) before the start of the admission process and contact the Organizing Institute, in case of any discrepancy.
- The list of documents required for applying is given in Annexure VI.
- Based on the Test Paper(s) qualified, a Candidate can apply to one or more academic programmes covered under that Test Paper(s), subject to the fulfilment of the MEQs and ERs of the Admitting Institute(s).
- All programmes to which the candidate is seeking admission must be selected, in the order of preference, during the application filling.
- The candidates will not be able to change the choices or their preferences after the last date of application submission / freezing choices.

## 5. ADMISSION PROCEDURE:

An Applicant will be considered for admission only to the programme choices filled in the Admission Form. There will be FOUR rounds of admission, in the normal case. If seats remain vacant, additional rounds may be conducted. Applicants receiving an offer in any of the rounds are required to login at <https://joaps.iitd.ac.in> within the stipulated time and choose one of the three options viz.

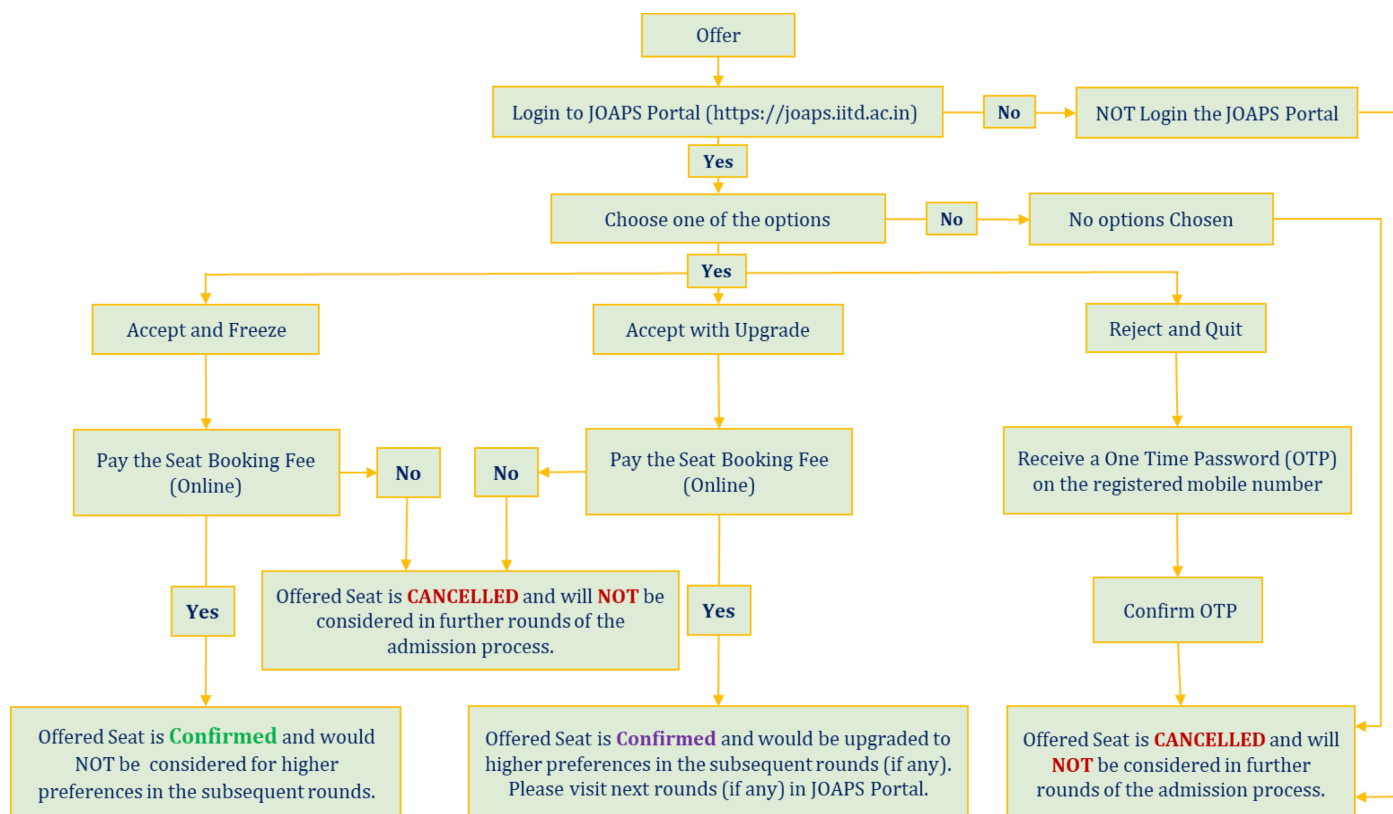
Options	Description
<b>(a) Accept and Freeze</b>	By choosing " <b>Accept and Freeze</b> ", the Applicant accepts the offered seat and would <b>NOT</b> like to upgrade to higher preferences in the subsequent rounds.
<b>(b) Accept with Upgrade</b>	By choosing " <b>Accept with Upgrade</b> ", the Applicant accepts the offered seat, but would like to upgrade to higher preferences in the subsequent rounds.
<b>(c) Reject and Quit</b>	By choosing " <b>Reject and Quit</b> ", the Applicant rejects the offered seat and would <b>NOT</b> like to continue in the admission process. The seat offered to the Applicant would be cancelled and the Applicant will not be considered in further rounds of the admission process. For " <b>Reject and Quit</b> " decision, the applicants will receive a One Time Password (OTP) on their registered mobile number. The OTP has to be entered to confirm the decision.

When an applicant chooses "**Accept and Freeze**" or "**Accept with Upgrade**" decision for the first time, the Applicant will be directed to an online payment portal to pay the Seat Booking Fee of ₹15,000/- for General/OBC-NCL/EWS category Applicants and ₹7,500/- for SC/ST/PwD category within the stipulated time period. The Seat Booking Fee will be transferred to the Admitting Institute and will be adjusted against the Institute Fee at the time of Admission.

- Based on the order of preferences given by the candidate in the Admission Form and corresponding rank(s) in the Merit List, the **First Admission List** will be prepared on or before **May 26, 2025**. The candidates are required to login to the portal to view their status.
- Applicants who are offered seat in the **First List** must login to Candidate Portal and choose one of the three options discussed above on or before **May 30, 2025**.
- If seats remain vacant after the first round of admission, a **Second Admission List** will be prepared on or before **June 08, 2025**. The candidates who chose "**Accept with Upgrade**" in the previous round are required to login to the portal to view their current seat allocation.
- Applicants who are offered seat in the **Second List** must login to Candidate Portal and choose one of the three options discussed above on or before **June 11, 2025**.
- If seats remain vacant after the second round of admission, a **Third Admission List** will be prepared by **June 16, 2025**. The candidates who chose "**Accept with Upgrade**" in the previous round are required to login to the portal to view their current seat allocation.
- Applicants who are offered seat in the **Third List** must login to Candidate Portal and choose one of the three options discussed above on or before **June 20, 2025**.
- If seats remain vacant after the third round of admission, a **Fourth Admission List** will be prepared by **June 30, 2025**. The candidates who chose "**Accept with Upgrade**" in the previous round are required to login to the portal to view their current seat allocation.

- Applicants who are offered seat in the **Fourth List** must login to Candidate Portal and choose one of the three options discussed above on or before **July 03, 2025**.
- The Applicants who were offered a seat can **CANCEL** the offer by logging into Candidate Portal and choosing "**Withdraw**". This option would be available from **June 07 to July 07, 2025**. The Seat Booking Fee (if paid by them) would be refunded after deducting a Processing Fee of ₹6,000/- by August 15, 2025.
- Offer letters from the admitting Institutes will be available for downloading by the candidates through Candidate Portal, after the final round of admissions. The Applicants who are offered a seat should report to the Admitting Institutes along with the required documents, as per their offer letter.

#### Note:

- I. Seat Booking Fee is ₹15,000/- for General/OBC-NCL/EWS category and ₹7,500/- for SC/ST/PwD category.
- II. In each round of offer (Admission List), candidates should login to the JOAPS portal to view their offer and status.
- III. Candidates who have **NOT** accessed JOAPS portal and **NOT** Chosen any options within the stipulated time period, the offered Seat will be automatically Cancelled and will **NOT** be considered in further rounds of the admission process.

**Important Points to Note:**

- a) Applicants are requested to periodically check the JAM 2025 website (<https://jam2025.iitd.ac.in>) for updates and the candidate portal for the status of their application. They should also check the messages sent to their registered e-mail ID and/or mobile number.
- b) Incomplete applications or applications that are not supported by valid documents will be rejected. The application fee, if paid would not be returned for applications that are rejected. The Application Form for admission will not be considered, if the fee is not received by the JAM Organizing Institute before the application deadline. No intimation regarding the rejection of application form will be sent to the candidate.
- c) Applicants who are not allotted a seat in a round may get a seat allotted in the subsequent rounds. Applicant who fails to accept a seat offered at any stage, will not be considered further in the admission process.
- d) Last date for the payment of fee for the seats allotted in each round cannot be relaxed in any case. If the seat offered is not accepted by the candidate or payment is not made within the stipulated period, the offer gets automatically cancelled. No other requests or correspondence on this matter will be entertained.
- e) Candidates should note that being in the Merit List of any Test Paper neither guarantees nor provides any automatic entitlement for admission. Admissions shall be made in order of merit and depending on the number of seats available at the Admitting Institute(s).
- f) The offer of admission to a candidate made during the central seat allocation process would remain provisional, subject to the fulfillment of all the requirements stipulated by the admitting institutes as per their deadline.
- g) The biometric (fingerprint) data of the candidate captured on the day of JAM 2025 examination will be used by the Admitting Institute for verifying the identity of the applicant and it has to match with the candidate being admitted.
- h) Payment has to be made using credit card/ debit card/ net banking/ UPI (additional Bank charges may apply depending on mode of payment).
- i) With regard to the interpretation of the provisions on any matter not covered in this Admission Brochure, the decision of the Organizing Institute shall be final and binding on all the parties concerned.
- j) IIT Delhi has the overall responsibility of coordinating JAM 2025. In case of any claims or disputes related to JAM 2025, the Delhi High Court (New Delhi) shall have the exclusive jurisdiction to entertain and settle any such disputes and claims.

**6. RESULT SHARING INSTITUTES:**

JAM 2025 Organizing Institute will coordinate the admission process of only the Admitting Institutes given in Annexure I. For admissions to Result Sharing Institutes, candidates will have to directly approach the respective Institute/admission body. JAM 2025 results will be used for admission to postgraduate programmes such as M.Sc. and M.A. at various NITs, IEST Shibpur, SLIET, DIAT through Centralized Counselling for M.Sc / M.Sc. (Tech.) Admissions (CCMN). JAM 2025 results will also be used by various other institutes such as IISER Bhopal, IISER Tirupati, IIPE and IISc Bengaluru. Additional details about the programmes and the admission process may be directly obtained from the respective institute.
